Gentlemen/Ladies:

This letter shall serve as Addendum No. 2 to the above RFP issued by the Orange County Transportation Authority (OCTA). Offerors are reminded that the proposal submittal date is at or before **2:00 p.m., June 28, 2021.**

Offerors are advised of the following:

1. A pre-proposal conference was held on June 8, 2021 at 10:00 a.m. via teleconference. The pre-proposal registration sheet is presented as Attachment A to this Addendum No. 2.
2. A list of Disadvantaged Business Enterprises within OCTA's market area is provided for reference and is presented as Attachment B to this Addendum No. 2

The following questions were submitted by the deadline:

1. Q – Previous “OCTA Future Procurement Lists” identified a \$500,000 budget for this effort. Can you please provide more information about OCTA's thought process to reduce the budget to \$300,000?

A – As noted on the CAMM NET website for the list of future procurements, “Dates for release of Request for Proposals (RFP) / Invitation for Bids (IFB) and approximate value of services are for planning purposes only and are subject to change.”

2. Q – The RFP states that, “The budget for this effort is \$300,000 for a three-year initial term.” Can you please provide more information about opportunities related to this project that might become available after the initial term?

A – The selected Consultant will provide services solely during the environmental process. The estimated costs and schedule for this process are noted in the RFP and were also communicated during the pre-proposal conference. However, if for one legitimate reason or another, more time is required to complete the environmental process, the contract and budget may need to be amended commensurate with the needs of the project/process. Please note that neither an estimated schedule for final design or construction has been approved.

3. Q – Can you please elaborate on what the expectation is with the integration of PublicInput.com into the public meeting/hearing process?

A – OCTA has a contract for services with Public Input. If OCTA opts to use Public Input on this project, the selected Consultant will be provided the required guidance and training to use and fully leverage the solution on the project. Therefore, at a minimum, Offerors shall possess the personnel and technological capacity to use the technology effectively, efficiently, and to the fullest extent. As such and as always, Offerors may offer analysis, strategic insights, and recommendations with respect to Public Input if and as they see fit.

Offerors are reminded to acknowledge receipt of this Addendum No. 2 in their transmittal letter and Exhibit B, "Price Summary Sheet." All changes addressed in this Addendum No. 2 shall be incorporated into the final Agreement.
