

- Hard copies of proposals will not be accepted by the Authority for this RFP

Proposal Submittal Instructions (continued)

- Authority has the right to:
 - accept or reject any and all proposals;
 - withdraw or cancel the RFP;
 - postpone proposal opening for its own convenience.
- Proposals received are considered public information
- Proposals are not to be copyrighted

Proposal Content (continued)

Cost and Price Proposal

- Only technical qualifications are to be submitted at this time
- No cost/price information is to be submitted
- Only highest ranked Offeror will be asked to submit a detailed cost proposal
 - Negotiations will commence based on both the cost and technical proposals

Evaluation and Award

 All proposals, timely received, will be evaluated using the following <u>evaluation criteria</u>:

Qualifications of the firm	25%
Staffing and project organization	40%
Work plan	35%

Evaluation Committee comprised of internal OCTA staff

Evaluation and Award (continued)

• "Short-Listed" firms will be invited to interview

• Interviews are scheduled for October 23, 2023







Scope of Work

- Facility inspection services for Westminster Avenue Bridge and Santa Ana River Bridge and the drainage systems within OCTA Pacific Electric Right of Way (PE R/W) on OC Streetcar project.
- All other related work as required in the contract documents.
- Bridge and drainage inspections shall comply with American Public Transportation Association (APTA) Standard, Federal Highway Administration (FHWA), California Department of Transportation (Caltrans) and local agencies requirements.
- In case of conflict among the standards and requirements listed above, Consultant shall comply with the most stringent one.

Inspection Staff Qualifications

- Bridge and drainage inspection personnel shall be qualified as required by American Public Transportation Association Rail Transit Fixed Structures Inspection and Maintenance Standard, section 2.3.
- Consultant shall include in its proposal the resumes and supporting documentation/certifications of its qualified inspection personnel.
- OCTA requires the inspection team to include a qualified program manager and a qualified structures inspection team leader.
- A qualified underwater inspector shall be on-call personnel and shall be available at OCTA's request.


