Clarification from the Authority: Answer 1:

Yes, parts shall be invoiced at cost with proof of invoice referencing what was paid, no mark up. Invoice costs for scissor lift & forklift rentals, any rental equipment are also (At Cost-No Markup) these are also included in the at cost with no mark-up and the firm will provide proof of invoice referencing what was paid.

2. Please confirm a General Contractors B license can carry the requested C-61" (Limited Specialty) or a "D-28" (Doors, Gates and Activating Devices Contractor) as Subcontractors?

Answer 2:

No, the contractor and subcontractor shall have the requested C-61" (Limited Specialty) and/or a "D-28" (Doors, Gates and Activating Devices Contractor) license.

3. Will the vendor be required to assist with Card Readers, Intercoms and Cameras at the Gate Entry area?

Answer 3:

No, to work on card readers, intercoms and cameras for gate area., this is not required.

4. What company is the existing gate or roll up door vendor at each location?

Answer 4: Action Door is the incumbent.
