NOTICE TO BIDDERS

SUBJECT: Request for Quotation (RFQ) 3-3046 "Industrial Air Compressor"

This letter shall serve as **Addendum No. 1** to the subject RFQ issued by the Orange County Transportation Authority (OCTA). Firms are reminded that the quote submittal date, via email, is at or before **11:00 a.m., January 25, 2024**.

Firms are advised of the following:

- 1. The Scope of Work and Price Summary Sheet have been revised to remove Champion Model HR25-12 and replaced with Champion Model HRA25-12 (Advantage Series), which is presented as Exhibit A, "Revised Scope of Work" and Exhibit C, "Revised Price Summary Sheet" attached to this Addendum No. 1.
- 2. The following questions were submitted by the deadline:

Question 1:

The specified unit is a base model and there are an array of accessories typically selected when buying it. Below are available accessories, are any of these required?

- 1. Air Cooled Aftercooler
- 2. Automatic Tank Drain
- 3. Vibration isolators
- 4. Totally enclosed fan cooled (TEFC) motor
- 5. Low oil stop control

Response 1:

OCTA prefers the HRA25-12 Advantage series compressor as they have been purchased in the past. The Advantage series compressor comes with the items listed below:

- Air Cooled Aftercooler
- Mounted Control Panel
- Low Oil Stop Control
- Electric Tank Drain
- Vibration Isolators

Question 2:

Are you wanting this unit to be a Champion advantage unit? This would include the low oil stop control, electric tank drain, air cooled aftercooler & vibration isolators.

Response 2:

Please see Response 1.

Question 3:

Attached please find our request of consideration of a couple models of Saylor-Beall air compressors "as equal" to the specified model. Saylor-Beall model numbers 92520-FP and 92512-FP.

Response 3:

The proposed Saylor-Beall models are not considered approved equals. The overall length is longer and may pose an issue given the small space OCTA has for the unit. Also, Saylor-Beall only provides a one (1)-year parts and labor warranty and does not have a separate warranty for the pump unit itself.

Question 4:

Air compressors are generally purchased with the following items in the basic package:

- 1. An aftercooler for moisture control.
- 2. A low oil stop control for machine security,
- 3. An electric tank drain, also for moisture control
- 4. A vibration isolator set, to allow for tank security and warranty.

Shall we show these items on the bid as options?

Response 4:

Question 5:

In addition, we note that OCTA personnel will install this air compressor. The compressor would be delivered by truck. Does your department have the ability to offload the air compressor from the delivery truck? (I.E., is a suitable forklift available at the delivery address?) If not, we can offer a liftgate delivery for an additional charge.

Response 5:

OCTA has a forklift available on site to offload the compressor when it arrives.

Question 6:

Page one, paragraph one states, "The budget for this effort is \$20,000.00 for a six (6)-month term." What is meant by the 6-month term? Does this

mean that the compressor may or may not be purchased during a 6-month period after the bid date, but if it is, it will be purchased at the bid price? Please clarify.

Response 6:

The purchase of the air compressor will be made once the lowest responsive, responsible firm is identified. The issued purchase order will be effective through August 31, 2024 to ensure that delivery and invoice payment are made before the contract expiration date.

Question 7:

If this is correct and the compressor is purchased at some future date, depending on the supply-chain status at that time lead times may be longer than 30 days. Will there be any allowance for this with verification from the manufacturer? Please advise.

REVISED SCOPE OF WORK Industrial Air Compressor

Background:

1.0 The Orange County Transportation Authority (Authority) is requesting (1) one Champion HRA25-12 (Advantage Series) air compressor unit for replacement of existing equipment at the Authority's Garden Grove Facility. The Authority's Facilities Department will install the industrial air compressor.

General Requirements:

- 1.0 Air compressor unit shall be manufactured by Champion, Model HRA25-12 (Advantage Series) or approved equal with the following specifications:
 - a. 25 Horsepower motor
 - b. 120 Gallon capacity tank
 - c. 3 Phase 460 Volt electrical
 - d. 60 Hertz
 - e. Approximate Dimensions (LxWxH) 72" x 30" x 66"
 - e. 2 Stage splash lubricated
 - f. PSIG Off setting 175
 - g. PSIG On setting 140
 - h. 90.1 CFM Delivered @ 175psi
- 1.1 The industrial air compressor pump unit shall have a (3) three-year warranty covering all materials and workmanship. Valves, controls, and accessories shall be warrantied for the first year. The air compressor package unit shall carry a one (1)-year warranty covering all materials and workmanship.
- 1.2 The industrial air compressor shall be delivered within thirty (30) days after receipt of order between 6:00 a.m. 2:30 p.m. Monday through Friday to:
