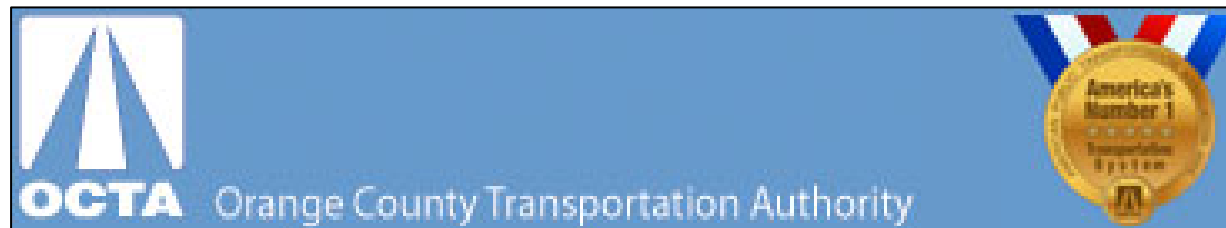

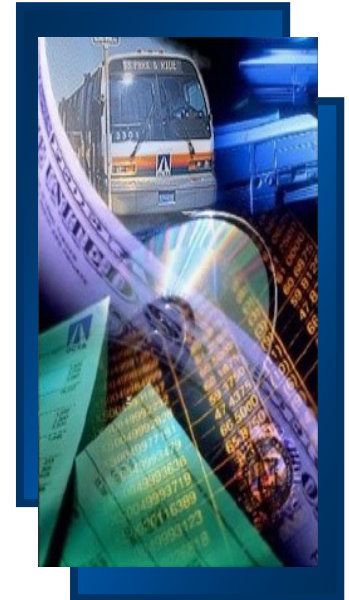

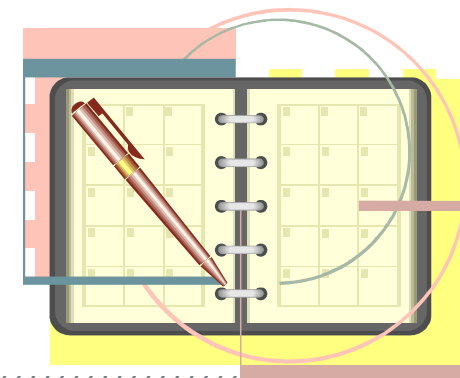

# Proposal Submittal Instructions

- Proposals are due by **2:00 p.m., March 20, 2024**
- Proposals are to be submitted electronically as specified in the RFP
- The link has an upload file size limit of 80MB
- The Authority will not accept hard copy proposals for this RFP
- Proposals and supplemental information received after the date and time specified above will be rejected

# Proposal Submittal Instructions (continued)

- Authority has the right to:
  - accept or reject any and all proposals;
  - withdraw or cancel the RFP;
  - postpone proposal opening.
- Proposals received are considered public information
- Proposals are not to be copyrighted

# Proposal Submittal Instructions (continued)

- Contract type is time-and-expense
- Conflict of interest
- Code of conduct

- Letter of Transmittal
- Technical Proposal
  - 1) Qualifications, related experience and references of Offeror
  - 2) Proposed staffing and project organization
  - 3) Work plan
  - 4) Cost and Price
  - 5) Exceptions / Deviations (Technical vs. Contractual)

  - Offerors are encouraged to review:
    - Article 3 - Scope of Work
    - Article 4 - Term of Agreement
    - Article 5 - Payment (Time and Expense)
    - Article 6 - Maximum Obligation
    - Article 9 - Insurance
    - Article 17 - Conflict of Interest/Prohibitions
    - Article 18 - Code of Conduct
  - Any exceptions or deviations need to be detailed on Exhibit G



# Evaluation and Award

- Proposals received, as instructed in the RFP, will be evaluated using the following evaluation criteria:
  - Qualifications of the firm 25%
  - Staffing and project organization 30%
  - Work plan 20%
  - Cost & Price 25%

# Evaluation and Award (continued)

- “Short-Listed” firms will be invited to the interview
- Interviews are scheduled for **April 11, 2024**
- Offerors are requested to keep this date available

# Award

- Award Process
  - Evaluation Committee recommends highest ranking Offeror to Finance and Administration (F&A) Committee.
  - F&A Committee makes recommendation to BOD.
  - BOD may accept / reject staff's recommendation.
  - All firms submitting a proposal will be notified of Award via CAMM NET.
