

#### Proposal Submittal Instructions

- Proposals are due by 2:00 p.m., March 13, 2024
- Technical proposals are to be submitted as specified in the RFP.
  - Submit one (1) original copy of proposal sealed and clearly identified on exterior of package as specified in the RFP.
  - Submit one (1) electronic copy of the entire proposal in "PDF" format on CD, DVD, or flash drive.
  - Contains no information regarding individual hourly rates.
- Packages clearly marked with the RFP number and title.
- \*PLEASE NOTE: This RFP requires separate hard copy submission of the price proposal. Please refer to Section II. p. 14 and Exhibit B.
- Proposals and supplemental information received after the date and time specified above will be rejected.

#### Proposal Submittal Instructions (continued)

- Authority has the right to:
  - accept or reject any and all proposals;
  - withdraw or cancel the RFP;
  - postpone proposal opening.
- Proposals received are considered public information
- Proposals are not to be copyrighted

  - -Offeror shall submit proposed pricing to provide services described in Exhibit A, Scope of Work.
  - Offeror shall submit Exhibit B, Price Summary Sheet, as a separate, sealed package from the proposal.
  - -NO information regarding individual hourly rates shall be mentioned anywhere in the proposal content.
  - Do NOT alter the Job Functions identified on the form.

#### **Evaluation and Award**

 Proposals received, as instructed in the RFP, will be evaluated using the following <u>evaluation criteria</u>:

<ul> <li>Qualifications of the firm</li> </ul>	25%
<ul> <li>Staffing and project organization</li> </ul>	30%
<ul> <li>Work plan</li> </ul>	20%
<ul><li>Cost &amp; Price</li></ul>	25%

#### Award

- Award Process
  - Evaluation Committee recommends highest ranking Offeror to Legislative and Communications (L&C) Committee.
  - L&C Committee makes recommendation to BOD.
  - BOD may accept / reject staff's recommendation.
  - All firms submitting a proposal will be notified of Award via CAMM NET.
