NOTICE TO BIDDERS

**SUBJECT: Invitation for Bids (IFB) 4-2167  
“ViewSonic Monitors”**

This letter shall serve as **Addendum No. 1** to the subject IFB issued by the Orange County Transportation Authority (OCTA). Bidders are reminded that the bid submittal date is at or before **11:00 a.m., April 11, 2024**.

The following questions were submitted by the deadline:

**Question 1:**

Would you please let us know if only requested ViewSonic monitors are approved for this bid, or if you’d consider bids for similar options in a different brand as well?

**Response 1:**

No approved equals will be accepted by OCTA.

**Question 2:**

In the official IFB, it states that the budget is \$200,000. Does that mean that bids that go over \$200,000 will not be considered?

**Response 2:**

All responsive bids will be considered. Per Exhibit B, Price Summary Sheet, it is emphasized that the items and quantities shown are for price evaluation only and do not imply any guaranteed minimum or maximum usage.

**Question 3:**

My ViewSonic sales rep has informed me that the monitor VP2768A is out of stock and will not be receiving any in the foreseeable future. The closest comparison would be VG2756A 2k (100W charging but does not have the same color accuracy. The VP2756-2k (non-docking). There is also the VP2768A-4K, which is the 4k version of the original request. Let me know which would be suitable for the company and we can move forward with a quote.

**Response 3:**

**Question 4:**

Does the County anticipate making any purchases that deviate from this list of products?

**Response 4:**

**Question 5:**

Will installation be needed or is the County installing in-house or by way of an already established third party?

**Response 5:**

Installation is not a requirement of this IFB.

**Question 6:**

Payment will be made within a reasonable time after inspection and formal acceptance of the equipment by the Authority. What is a 'reasonable time after inspection and formal acceptance of the equipment '? Are the payment terms Net30? This is not clear.

**Response 6:**

Per Exhibit A, Bid Form, unless otherwise stated, payment terms are Net 30 days.

**Question 7:**

All items are subject to final inspection and acceptance by Authority at destination. Final inspection will be made within a reasonable time after receipt of items hereunder. What is a 'reasonable time after receipt of items'? If this period is after 30 days, then a re-stocking fee may be charged by the vendor and the County will be required to pay this fee.

**Response 7:**

Final inspection is generally completed upon receipt of goods.
