SUBJECT: Invitation for Bids (IFB) 4-2254

Heating Ventilation and Air Conditioning Maintenance and

Repair Services

This letter shall serve as **ADDENDUM No. 1** to the above subject IFB issued by the Orange County Transportation Authority (OCTA).

A. Response to questions received from Offerors by May 15, 2024:

1) RFP page i/12 - Page i of the IFB states that we must email Exhibit H to the undersigned "no later than noon May 30, 2024." Page 12 of the IFB states that we need to email Exhibit H to the undersigned no later than 10:00 a.m. on May 30, 2024. Please confirm the time by which we need to submit Exhibit H. (Sue to Answer)

Answer: No later than noon May 30, 2024.

2) What is the Authority's preferred printed page size for Exhibit B Price Summary Sheet? Can we print the Exhibit B Price Summary Sheets in landscape orientation or 11x17 page size to ensure all content is readable for inclusion in our bid?

Answer: OCTA's preferred printed page size for Exhibit B Price Summary Sheet is standard letter size (8.5" x 11"). Printing the Exhibit B Price Summary Sheets in landscape orientation or on 11x17 page size is not permitted.

3) The Santa Ana Base EVAPCO Cooling Tower is no longer operating and is no longer being utilized. Will PM service still be required for that asset?

Answer: No

4) If crane services are needed, what are the required notification and documentation procedures?

Answer: Contractor must rent their own equipment.

5) The IFB 4-2254 regarding Air Filters States that MERV 8 PLEATED are to be provided for the filter changes. Merv 8 filters are no longer available and have been replaced with Merv 10. Please confirm if Merv 10 is acceptable.

Answer: Yes.

6) Paint Booth Heaters located at (4) difference sites. IFB 4-2254 states that Annual servicing to be provided in September. Would this service start this September 2024 or September 2025?

Answer: September 2024.

7) How many filters changes are required?

Answer: According to price summary sheets.

8) What type of Certifications are you looking for?

Answer: HVAC, specifically CAA608 UNIVERSAL.

9) The IFB asks for filters to be changed on an as-needed basis, while the price summary sheet states that some equipment should be serviced every two months, and some equipment monthly. For the purposes of this bid, should we price the filter changes as happening every month for the CC MAU, GG MAU and SA MAU units, and every two months for all other equipment?

Answer: Price according to price summary sheets.

10) What is the current controls system at these locations?

Answer: Various units

11) This IFB states that this maintenance agreement is NOT a Full-Service Contract. Please define Full-Service.

Answer: This contract is everything except installation.

12) Would like to request a 2-week extension of the due date from May 30th to June 13th.

Answer: No, the schedule does not allow for an extension.

13) Would like to request a second job walk.

Answer: No, the schedule does not allow for an extension.

14)Are we able to request the answers to the questions be sent back by May 30th.

Answer: No.

15) Is there water access on the roof for all the equipment and to adequately wash the coils?

Answer: Hose bibs are available but must follow SWPPP.

16) The scope of work indicates water treatment is to be included for the cooling tower. Can you please provide the scope of work for the tower. Can you please provide the Contractors name who is performing the water treatment now.

Answer: Not necessary, cooling tower is inactive.

17) Who is the incumbent contractor that held the previous contract?

Answer: Allison Mechanical.

18)On page 3 under, "Corrective Maintenance", please clarify if repair parts and equipment are billable except for belts and filters. If deficiencies are noted on equipment, the contractor shall provide a written quote/proposal for the repairs and will not move forward with the repairs until it is approved. These repairs will be billable. Is this a correct statement?

Answer: Repairs are billable at cost.

19) What type of Building Automation System do you have in the buildings. If we need to include maintenance on Controls, we need to know the what type of system. How many VAV's do you have in the buildings?

Answer: Details were available on job walk.

20)Scope of Work states, "Bi-Monthly" maintenance. Confirming that this is every other month for a total of (6) six visits.

Answer: Yes, Bi-monthly is every two months.

21)For the boilers annuals – are we replacing burners and ignitors? Are we to provide analyzer testing?

Answer: Yes.

22)If this is an all-inclusive maintenance contract, can we request an equipment assessment to take place noting all deficiencies on the

equipment with the understanding that equipment deficiencies will be fixed prior to the commencement of the contract?

Answer: No.


