

  - postpone proposal opening for its own convenience.
- Proposals received are considered public information
- Proposals are not to be copyrighted

    - Complete in entirety
    - Fully burdened rate for each test or service
    - Include firm's standard test and inspection services
    - Proposed annual escalation
    - Proposed markup to prevailing wage rates

Authority cannot pay for hours other than work actually completed, such as reporting time pay.

Project Overview and Scope of Work

#### Summary of Project

- Scope of Services includes, but not limited to, performing on-call materials testing and inspection at OCTA's transit facilities, including five bus bases, two park & rides, five transportation centers, the Transit Security and Operations Center and the OC Streetcar Maintenance and Storage Facility.
  - ➤ The selected consultant will be required to provide the required work force, materials, equipment, and testing facilities for soils and materials testing and inspection services under this RFP scope of work.
  - ➤ Inspections and materials testing under this RFP are listed in Exhibit B of the RFP. The consultant may be required to perform other testing and inspection services as directed by OCTA.
  - ➤ The consultant is required to provide a list of standard testing and inspection services not specifically listed in RFP Exhibit B which the consultant firm undertakes.

#### Summary of Project (continued)

- ➤ California test methods are required. The consultant shall have a quality control plan in effect during performance of the work of the RFP, including quality control, quality assurance, and equipment calibration programs for the laboratory.
- ➤ The consultant is required to submit certified test results following sampling and testing on the due dates. Daily inspection reports are required to be submitted to OCTA on the day following inspection.
- ➤ Invoices submitted for payment must contain the required information and certification.
- ➤ Prevailing wages are required, the consultant shall include certified payrolls with invoice submittals.
- ➤ OCTA's bus bases, operate 24 hours a day 7 days a week and must remain fully operational at all times.










# Health, Safety and Environment (HSE) Level 2 Safety Specifications

# Safety Requirements

- Safety is Paramount, Everyone Needs to Complete Tasks Safely Everyday, Family Depends on You!
- Review the proposal Health, Safety & Environmental Requirements
- Contractor shall comply with CCR Title 8, Section with California Code of Regulations (CCR) Title 8, Section 3203
- Contractor shall comply with the Policy or Program of the Company's Substance Abuse Prevention Policy that complies with the most recent Drug Free Workplace Act
- Contractor shall comply with CCR Title 8, Section 5194 Hazard Communication Standard
- Upon contract award, the contractor within 10 business days shall designate an on-site health and safety representative and provide a resume and qualifications to the Authority project manager, upon request, within 72 hours
- The Contractor's HSE Representative shall preferably hold a certification from the Board of Certified Safety Professionals (BCSP) and at a minimum possess an OSHA 30-Hour training certificate, and have five years of demonstrated construction/scope experience enforcing HSE compliance on construction, industrial or similar project scopes
