- **Q1**. Please confirm for 3.0-6 Safety Officer, whether it is necessary for the last two projects administering the safety in construction discipline has been contracted with OCTA?
- A1. No, it is not necessary for the last two projects to be contracted with OCTA.
- **Q2**. We respectfully request an extension of the RFP deadline. When the RFP was initially advertised, schedules and resources were aligned with the original timeline.
