

Project Overview

Trabuco Rose Preserve is a property that OCTA maintains as an open-space preserve in Trabuco Canyon, northwest of Rancho Santa Margarita:

- Yellow line represents existing gully in need of repair
- Portion of gully previously repaired in 2021
- Gully is adjacent to a fire access
 road
- Primary access to site is along Trabuco Oaks Dr.

Project Scope

Scope involves:

- Adding a geotextile liner as a base for a portion of gully
- Introducing a tiered series of rock check walls and pools
- Layering various rock gradations for a base
- Providing 12" of soil intermittently
- Protecting existing edges with jute matting


Safety Requirements

- Safety is Paramount, Everyone Needs to Complete Tasks Safely Everyday, Family Depends on You!
- Review the proposal Health, Safety & Environmental Requirements
- Contractor shall comply with CCR Title 8, Section with California Code of Regulations (CCR) Title 8, Section 3203
- Contractor shall comply with the Policy or Program of the Company's Substance Abuse Prevention Policy that complies with the most recent Drug Free Workplace Act
- Contractor shall comply with CCR Title 8, Section 5194 Hazard Communication Standard
- Upon contract award, the contractor within 10 business days shall designate an on-site health and safety representative and provide a resume and qualifications to the Authority project manager, upon request, within 72 hours
- The Contractor's HSE Representative shall preferably hold a certification from the Board of Certified Safety Professionals (BCSP) and at a minimum possess an OSHA 30-Hour training certificate, and have five years of demonstrated construction/scope experience enforcing HSE compliance on construction, industrial or similar project scopes
